American Academy of Social Work and Social Welfare To Induct Fellows

The American Academy of Social Work and Social Welfare (AASWSW) has selected fellows for their distinguished accomplishments as scholars and practitioners dedicated to achieving excellence in high-impact work that advances social good. They will be inducted during public ceremonies at the Society for Social Work and Research (SSWR), Conference, January 13, 2017, in New Orleans, Louisiana.

Election into the AASWSW is through a process common to many scholarly academies involving confidential nomination by current Fellows and election by a supermajority of Fellows. The establishment of the American Academy of Social Work and Social Welfare in 2010 represented an effort by the leading national social work organizations to strengthen the field's capacity for rigorous analysis that can guide effective human services policies, programs, and practices, is intended to encourage and recognize outstanding research, scholarship, and practice that contribute to a sustainable, equitable, and just future. The Academy aims to influence social policy by serving as a frontline source of information for the social work profession as well as Congress and other governmental and nongovernment entities. It promotes the examination of social policy and the application of research to test alternative policies, programs, and practices for their impact on society. AASWSW also celebrates excellence in social work and social welfare research, education, and practice. The Academy has recently launched the Grand Challenges for Social Work Initiative.

"The Fellows of the Academy are all strong leaders in integrating scientific methods and social work practice and policy and an enormous resource for the field. I am delighted

that 15 more Fellows will be inducted as this will significantly strengthen the range and impact of our work to address the grand challenges facing our society." said AASWSW President Richard Barth, Dean of the University of Maryland, School of Social Work.

Induction will be preceded by a talk given by Fellow Michael Sherraden, George Warren Brown Distinguished University Professor, and Director, Center for Social Development, Washington University in St Louis.

This year marks a special Induction Ceremony, as the Academy welcomes incoming President, Sarah Gehlert, E. Desmond Lee Professor of Racial and Ethnic Diversity, Washington University in St Louis, and Vice President, Gail Steketee, Dean, Boston University, School of Social Work. Additionally the conference theme is a Grand Challenges for Social Work: Ensuring Healthy Development for All Youth.
